BY-LAWS AMENDMENT - Not least, but last.

Basically, the petition has the effect of removing the mandatory submission of scores in behalf of the NCCC by NCCC member participants. The full text of the petition is as follows:

"So that the purpose of the Northern California Contest Club may be carried out in the spirit expressed by Article I, Section 2 of the club constitution, we, the undersigned, being full members of the Northern California Contest Club, petition that Article II Section 5 of the constitution be amended by deleting the present text and inserting the following in its stead:

Section 5

Full members may submit their contest scores in the name of the Northern California Contest Club."

Remember, the vote on the proposed amendment will be taken at the next meeting, February 26!

QST OPERATING EVENTS COLUMN - de Ellen White, WLYYM

As many of you might have noticed an operating events column was started last month in QST, and is handled by Ellen White. She does an excellent job of collecting together, on one or two pages, contest material which was previously scattered throughout the entire magazine. The February column, found on pages 95 and 114, were of great help in compiling the calendar which appears below. Unfortunately, QST seems to be following their traditional policy of ignoring contests sponsored by CQ magazine (and other similar organizations), evidently still believing that the act of reporting somehow signifies approval. Thus, the February issue devotes 2½ column inches to announcing the Colonie H.S. Annual "Operations Day", the VE2 contest (limited to VE2's only) and the TRW Systems QSO Party, while the CQ WW WPX SSB Contest, which attracts world-wide participation, is totally ignored. (Say, isn't TRW a profit-making organization?) On the other hand, the column is useful, well-done and easy to read, so perhaps we should be thankful. Progress sometimes comes in tiny steps, but progress it is. End editorial.
