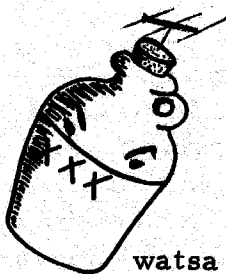

A PRESSAGE FROM THE MESIDENT

The '77 ARRL DX Marathon did seem much more enjoyable this year. We experienced better band conditions, good JA and EU activity and especially the gang - the spirit of those members active made the contest a treat that should not have been missed. Preliminary results show a score of about 40 million points, which is not too bad for a first serious club effort!! We still have much work remaining to gather all the scores in the NCDXCC.

My biggest kick in the affair was watching some of our younger operators learning the tricks of the trade at the PAA three-transmitter phone operation. Our front-line operators averaged 16 years of age (oh, to be 16 again!) and did a terrific job of running JA's and hunting down multipliers.

I hope most of you will make the Fresno scene on the first weekend in April. Lots of socializing, BS-ing with other contesters from around the state and world will abound, plus you will have the opportunity to operate the KB station with big KLM antennas mounted atop the Hilton. It should all add up to a great time.

The Friday night before Fresno will host the traditional beer-blast (BYOB) at PAA's PAD. (The PAD is one of San Jose's highlights. It is the only licensed, multi-bedroom ham shack with

a building permit for the first weekend in April to erect a 160 meter beer-can vertical phased array.)

Our March 28 meeting features include the slides by WB6DSV of the 5W1 DX-pedition, FD preliminary planning and a wrap-up of the ARRL DX Contest. Due to the effort in obtaining scores for the JUG, you may not receive this until after the meeting, but be there anyway!! These topics will be washed down by the usual and familiar-tasting beer at the NCCC Pizza parlor. (Those of you who have not been at the pizza feed, the club members literally take over the local establishment and consume large quantities of breath-defying food and slosh down at least as large quantities of the familiar Colorado brew.)

The Following is taken from QST, March, 1977 page 66: (Minutes of the 1977 Annual Meeting of the Board of Directors, The American Radio Relay League, Inc. January 20-21, 1977)

" 49) On the motion of Mr. Gmelin (our Pacific Division Director and Member of the NCCC and resident of SCV, Ed.), seconded by Mr. Sullivan, unanimously VOTED that, in order that operating skills rather than caliber or quality of station equipment will determine the standing of amateurs entering operating contests, the Contest Advisory Committee recommend to the BOD ways of changing contest rules so that transmitter power, height and gain of antennas, and number of transmitters and receivers used, shall be a part of the factors determining final score. These recommendations shall be presented by the Liaison Director at the July, 1977 Board Meeting."

All of us in the NCCC and those of you who are not NCCC members, but who do read this newsletter and all of us who are interested in the well-being of amateur radio in general : in amateur radio contesting specifically, should re-read these words from the ARRL BOD meeting until we fully understand the immense

in fact they can inflict upon amateur radio contesting and possibly any form of competition sponsored by the ARRL. This type of logic is contrary to even life in the real world. It seems to be an attempt to legislate mediocrity. Let us take just a quick glance into what this motion could lead to without being too ridiculous.

Most all of us who are actively involved in the field of amateur radio contesting are people who like to compete, right? Sure, then what we do is to strive to do our utmost to win, but if we cannot win, then we strive to do our best in the final standings. If we don't hit the mark one year, we know that there is always next year. So what do we do in the intervening year?? Of course - we improve everything we can to do better. This includes station improvements, antenna upgrading and a review of our particular operating skill and habits during the contest. Notice that there are more points worth improving and working at other than just operating skill. If we were all to run 100 watts to a 5 foot vertical over a sheet of metal measuring 3 feet by 3 feet and use one receiver, who would win?? Probably still the same fellows!!! What is definitely lacking in this proposal to legislate handicaps is that legislation of this type hinders and limits the level of competition - it does not increase it.

This kind of handicap was tried before with the low-power multiplier in SS being the last one relevant to our club's major efforts. It met with poor success, since low power is now a separate category. It should be evident that even a simple attempt at handicapping does not work. Just imagine for a moment all the possible variables that should be taken into account:

I. Transmitter

A. Quality

1. Filters
2. Broadband or manual tuning
3. Reliability - solid state or tubes

B. Power input and output

C. Amplifier

You know, it's not worth the trouble to continue. The greatest variable in the whole list would be LOCATION. How do you legislate that??

Let's face it. If the BOD would leave the CAC alone so that it could do what IT believes is best for contesting, then the BOD could go on and try to reduce our dues and provide useful services.
