1984 SS A CLOSE RACE

CW was sweet music to the ears of NCCCers W6OAT (operating WA7NIN), W6XX (operating three bands only), and N6BV (operating N6RO), who defied marginal propagation, especially on Sunday, to score over 1,000 QSO's in the CW SS, thus qualifying for the coveted KB-1000 single-op trophy. All in all, about 50 club members, inspired by WA6VEF's presentation of SS tapes 1-3 at our last meeting, pounded brass in the 1984 SS.

Despite all this effort, however, our principal known competition, the Mad River Radio Club, is close behind us in the club competition as we approach the phone weekend. Let's all get on and teach them and the rest of the country the meaning of KB. In the October Mad River newsletter, their president boasted: "Don't forget that we have accepted the NCCC challenge in the SS. . . If we can get everyone on for both weekends we will beat the rascals." Are we going to take this kind of talk lying down? Centered in Marion, Ohio, the Mad River 175-mile radius encompasses all of Ohio, plus parts of Michigan, Pennsylvania, Indiana, Kentucky, and West Virginia. Dozens of Maddies attempted the CW contest.

In the upcoming phone weekend, don't forget to work your fellow club members at 0700Z (11 p.m. Saturday night local time) on or about 3.900 MHz. And we've set up a sked with VY1CC at 14.155 MHz at 2300Z (3 p.m. local) both

Saturday and Sunday; however, a similar sked for the CW weekend didn't pan out, so don't get your hopes up too high.

Post contest, remember to send in your duped and summarized SS logs to Newington, and a copy of your summary sheet to VPCC Bob Wilson, N6TV, 51 Cheltenham Way, San Jose, CA 95139.

In recognition of the DX Club's magnanimous support of our successful CQ Worldwide efforts in 1981-83, we are encouraging all joint members of the NCDXC and NCCC to submit their 1984 CQWW scores on behalf of the NCDXC. The NCCC will also be submitting a club score in the CQWW, to provide a reporting vehicle for those who are members of just the NCCC. To submit your 1984 CQWW score on behalf of the NCCC, it will be necessary for you to send your logs to CQ Magazine, and to send a copy of your summary sheet to me at 25811 Estacada Drive, Los Altos Hills, CA 94022. I will then submit the official NCCC entry to CQ.

At the November 26 general membership meeting to be held at our regular hideaway, we will show a videotape of the North Texas Contest Club. This tape includes a visit to the QTH of our old friend, KN6M/5, and features the 30-tower superstation N5AU. N6TV also threatens to bring to this meeting the SS bullsheets with actual scores superimposed thereon.

We all know that Rusty, Ken, Carl, and other big gun superops can and will wail for us in the phone SS. If enough of our little guns and popguns get on, we'll be able to celebrate as well as salivate at our December 15 Christmas Banquet for OMs and XYLs, described elsewhere this Juq.




