Just When You Thought NOBODY Wanted to Work a W6......

Hey! It's time again to get yourself ready for the first "biggie" of the fall contest season! That's because we're only two and a half weeks away from the premier state QSO party on the contest calendar--our own NCCC-sponsored California QSO Party.

This year's CQP promises to be another major event for our Club. Some 75 NCCCers have indicated that they'll be active for the Party (see the "Who's Going To Be Where" article elsewhere in this JUG), with 15 of our ops planning CQP county DXpeditions. Our massive awards program, which includes the personalized wine awards, has continued to generate enthusiasm and interest throughout the state and the country. And our CQP publicity campaign, in which we've mailed 2,000 promotional brochures to contesters and DXers nationwide, should culminate in some sizable pile-ups, especially at the start of the test!

It's a pretty sure bet that we'll again have activity from all 58 California counties. As of this writing (September 11th), we have confirmed fixed station operations from 49 counties, and mobile activity from 4 more. Counties not spoken for at this time include Mendocino, Stanislaus, Mariposa, Kings, and Inyo. However, we're still awaiting word of fixed operation from some of these places, and our core of mobile specialists (N6BT, WA0YQM, N6NKN, and WB6SHD/AA4NC/AA4GA) have yet to set their county itineraries. All in all, they should easily be able to fill in the gaps in the map, and 58 counties should be a snap.

A few operating reminders about the contest--first and foremost, be sure to check the CW subbands on the half hour. If W6s show up en masse at the published half hour times, it will generate more out-of-state interest, which will in turn result in W6s staying on code for longer time periods. Ultimately, scores go up, as CW QSOs are worth 3 points versus 2 on Phone, and the extra CW activity makes the Party a lot more interesting for those who hate SSB!

Second, the sked time for 160 meters is 0500Z (this can be VERY productive—in 1987, K6NA (N6TR op) made 98 SSB and CW Qs on 160 during this hour!), and the time for 80/75 is 0700, although activity may be heard on 75 and 80 as early as 0400. Finally, don't overlook 6 and 2 meters as valid QSOs may be made there. On 2 meters, try 147.54 at 2000, 0000, and 0400Z.

Finally, there are two rules changes for 1989. First, single ops and multi-singles are allowed only one transmitted signal at a time. What this does is prohibit the technique of using two rigs to call the same CQ simultaneously on two bands! Also, the California Club plaque now requires a minimum of five entries. By the way, the Northern and Southern CA Contest Clubs are both ineligible for this award, so it won't count if you write in "NCCC" or "SCCC" on your summary sheet.

After the contest, be sure to send in your log, no matter how large or small, as the success of the CQP is judged largely by the number of entries we receive. The address is NCCC c/o Gary Caldwell, POB 8014-56, Blaine, WA 98230.

So, now's the time to dust the cobwebs off the rig and amp, check the SWR of your antennas, number the logsheets, practice sending CW, and bring out the throat lozenges.

KAGING--Louese will also activate San Mateo Co., as will Rusty, W60AT.

K4TKM--Brook plans to juggle house guests and CQP activity from San Francisco Co.

K6LRN--Full blast from Marin County!

Middle SCV Report de Russ, K6KLY.

Look for N6BT, WA6VEF, and VE7NKI to be operating mobile from most of the counties in the northern part of the state. They ll be running gain antennas on 10, 15, and 20 (mobile?—yes!), as well as a KW amplifier.

Jack, W6ISQ, will be active from San Mateo Co., while Ed, AJ6V, will be on from Santa Clara.

K6TMB and W6SZN--multi-op from SZN's cabin at Lake Tahoe, Lou and Kip hope to bring home both QSOs in the log and \$\$\$\$ from the local casinos. (Placer Co.)

W6XX-Pete will be in KL7 land during CQP weekend, and plans to be on the air, time permitting.

Lower SCV #1 Report de Stan, K6MA.

Santa Clara Co.--N6BIS and W6QHS plan activity.

Santa Cruz Co.--look for activity from KA6W, who may be joined by K4UVT.

Sutter Co.--This rare county will be put on the air by Ken, W6XB.

Lower SCV #2 Report de Scott, NIEE.

The Pacific Division Convention—The convention station, W6UW, will be put to good use this year as it will be staffed by NCCCers who'll operate in the CQP. Scheduled to be there are KB6NLO, KJ6FD, K6WJ, N6XI, and AD6E, if he doesn't make it to Tuolumne Co. Be sure to stop by the station if you plan to spend any time at the convention.

N6TV--Sporting a new tower, antennas, rig, and amp, Bob will be operating CW only from Santa Clara Co. in quest of W6UE's CW QSO record.

KA6LAF--Look for Jeff to be on part time from San Luis Obispo.

KI6CG--George is looking toward another county record--this time portable from Monterey Co.

AG6D--Al plans a limited effort from Santa Clara.

W6CF--Jim will be on 5 to 10 hours from Santa Cruz Co.

NIEE--San Francisco record, here we come? Scott will again be operating

Upper and Lower East Bay Report de Mac, W6BSY.

Alameda County--There should be lots of activity from here again in 1989, with planned operation by N6CCL, K6AUC, N6DA, N6EK, and K6SIK.

K6CSL--Bert says he'll be in Tulare Co. for the CQP.

W6BSY--Mac will be operating portable from Yuba, and may have the company of Bob, W6RGG. Bob will be on from Alameda if he doesn't go with Mac.

WAGYQM--Larry will operate mobile, making sure that El Dorado, Stanislaus, and Mariposa Counties are covered.

KS6H and N6ZB--Several times the multi-multi champs of past CQPs, Jim and Bob will again be active portable from Merced County. WR6R--Al will be on from K6ZM in Contra Costa Co.

Eastern East Bay Report de WA6VEF/VE7.

KI6EZ--Alex will be exercising KG6GF's station in San Benito County. Solano County--WX6M will be on, mostly on SSB, and neighbor K6HIH will also be active, primarily on Al.

Contra Costa County--Expect lots of RF to emanate from this county, in the form of efforts by NB6L (if he doesn't go to Madera), WB6MZQ, N6RO, K6ZM, AK6T, and a multi-op by N6VV, K6PJY, and K6XV.

K6RK--Chuck'll be on from his portable QTH in Calaveras County.
AI6V--Carl will be active full-time if he can get home in time from a rental convention in Arizona. Home is Nevada County.

Sac Valley Report de Tim, NC7K.

N6IG--Jim will be on full bore from W6GO in Sacramento Co.
K3EST--Bob says he'll finally put up his tri-bander and try the CQP from home in Yoyo, no, Yolo County.
NC7K--Tim will be in the hunt if time and work permit.

San Joaquin Report de Duane, W6REC.

WC6H--Rich will be on as much as he can from San Joaquin Co.
N6TIB--Bill, last year's top CA Novice/Technician, has upgraded his ticket and will be on low power from Amador Co. in a full blast effort.

W6REC--Duane will be on from the far reaches of Modoc County.

Other CQP Rumors

Scuttlebutt has it that Tree, N6TR, will be driving from home in Portland, OR, to San Diego, where he'll do the CQP from K6NA . . . A couple of out-of-state regulars will be trying the test from CA this year--AA4GA and AA4NC will be going mobile with WB6SHD. Somehow, the thought that people are actually going on DXpeditions TO California is strange . . WJ6Q reports that EU recordholder UP2BKW (op of UP1BWW) is looking to best his 34K 1988 score, and that he has been promoting the Party among Soviet contesters . . Info has been sketchy as to who's going after the out-of-state title. We'll just have to wait and see.

The contest is for both modes, phone and CW, but the winning scores are usually determined by CW QSOs.

When to CW?? --- as often as possible and as long as it is productive. The CW QSO is worth three points vs. two points for a phone QSO, so a good rule of thumb to use is that if the CW rate is 1/minute (60/hour) stay on CW. This equates to 90/hour on phone in terms of QSO points.

--- concentrate on CW the first day.

--- 160 CW -> 0500Z one time (phone & CW)

--- 80 CW --> if have good antennas, go between 0430-0500Z and stay less than 30 minutes.

If 20 is good and not much 40, do not go to 80.

--- 40 CW --> if 20 is hot, check 40, but probably stay on 20. The night is long.

Low Bands --- follow the activity, as it tends to shift from one band/mode to another.

When to change bands --- notice if you are staying too long as you progress downward. If there is nobody left, you have probably stayed too long!

In 1988, 'VEF (at N6BT) was on 10 Mtrs at 0100Z and stayed until 0215Z before moving down to 15 Mtrs. There, he stayed only 30 minutes (until 0245Z), which was not the-best combination between 10 and 15. He then spent 1 1/2 hours on 20 Mtrs and was full-time on 40 Mtrs at 0500Z. The QSOs were about 130CW & 70 phone on 40 Mtrs. The strategy was to hit the high bands, although this is rare to be so successful. The phone QSOs on 20/15/10 were about 204/230/1535!

Smaller stations --- best advice is to follow the activity and hang around by the bigger/higher rate signals from California. They will draw the activity and this will be beneficial, compared to being too far away, where nobody is likely to find you as easily. (Note - don't get too close!). Start at 1600Z on 10 Mtrs and go to CW at 1630Z to get the "cream of the crop." Try to stay on the highest band possible, without running out of activity.

VE multipliers --- go to 14.150 plus a hair and call CQ for the ones you need.

General notes, PORTABLE and MOBILE --- power and good antennas, in that order. Running 100 watts mobile is very frustrating and an amplifier will make all the difference. An amplifier will require a generator, so a small trailer for the mobile station will be helpful. The trailer can also double as an antenna support. Check to see what the actual power requirements are for the equipment being used.
