Many other club members also are using various contest software packages to improve their score and/or eliminate the after-contest paperwork.

If you have been using contest software, bring your opinions about what does and doesn't work well. Anyone not using these programs, bring your questions and find out whether this is the time to start.

Minutes of April meeting

The April NCCC meeting was held April 21, 1990, at Miguel's Restaurant, Hayward, Calif. President Carl Cook, AI6V, called the meeting to order at 8:00 p.m.

Bert, K6CSL, read a letter from the Naval Communications Station, San Francisco, inviting NCCC members to operate from NPG during Armed Forces day, May 19. There will be an organizational meeting in Vallejo on Apr 28. NCCC is invited to send a representative. Bert will not be able to attend and is looking for a volunteer. N6TV will look for a representative. It was generally agreed that this is a great opportunity to operate a 40 kW station (!) and should be supported.

Pat, AK6T, read a packet message from Rich, KI3V, that was sent to all board members. Rich says that, as a relatively new member, he is unaware of the many awards and their rules and

would like them documented. WZ6Z volunteered to do the document ation.

In addition,Rich noted that the Founder's Award went to NC7K, who scored 1,690,597 points, yet Rich scored 1,720,590 points. It was generally agreed that, if these scores are correct, an error was made and the club owes Rich an apology. (See Scores item, p. 6 — Ed.)

N6TV read a mailgram from K6TMB who noted that NCCC took first place in the club competition for 1989 WPX (applause).

N6TV announced that next month's meeting will be May 18 at Miguel's Restaurant in Hayward.

N6IP, Bob Wolbert, was elected to club membership by unanimous vote. Bob lives in San Jose. He lists his contest experience as including CQWW PH/CW, ARRL DX PH/CW, IARU, CQP, SS, and ARRL CD parties(!). He prefers CW, but will operate phone. Bob also holds the callsign 7J1AGQ in Japan.

This being the April meeting, AI6V formally nominated the slate of new officers and board members:

There were no other nominations. K3EST moved to elect all those nominated; WB6MZQ seconded. The motion carried unanimously. (Note: As past president, AI6V remains on the board of directors.) Since W6ISQ could not be present, AI6V continued to chair the meeting.

W6RGG presented AI6V with a plaque to commemorate his past year as club president.

N6TV initiated a discussion for club contest priorities. An all-out effort to win CQ WW in 1990 was by far the most popular. Several DXpeditions are in the planning stage, so winning CW WW seems to be a realistic goal.

The formal part of the meeting was adjourned at 8:40 p.m.

Ken Keeler, N6RO, then entertained us with slides showing the evolution of his top-performance station on his Oakley spread. Included were shots of the WZ6Z crew setting a new world record and becoming the new multi-multi champion of the US in last year's CQ WW WPX.

Comments by President Casual Contester

Everybody knows I was elected to this Prexy job by default! The real president should be Louese, KA6ING. It was only at the last minute that she decided to let the reins of government slip out of her grasp. As a peace offering to her faithful followers—the entire club—she generously offered (so it is rumored) to bake two cakes for every meeting. These will be large devil's food cakes with thick fudge frosting and chopped nuts on top. One will be presented to the president and the other to the rest of the assemblage. Each person is charged with bringing his or her own spoon or fork. Can hardly QRX.

You realize that you voted in a casual novice contester, not exactly a 200-per-hour-QSO type like most of you. I can't write that fast, nor can I find the keys on a typewriter (computer) that fast. And I haven't thought that fast in a long, long time.

For example, my very first contest was in the fall of 1935 (I was W2ISQ then). I'm not even sure what contest it was, but part of the exchange was your QTH. My code speed was about 12 wpm (FCC code speed was 10 wpm for a ticket), and I called this fella at that speed. He came back about 20 wpm on a bug — fantastic. Well, I got about one letter in 10. He gave me an RST, which I got on about the third try, and what had to be his location. I copied something like ME...H... "AGN pse". ME..CH... "QTH agn pse". I asked for a repeat seven times. He could not just turn his VFO and get away because he was crystal controlled. Most everybody was then. He could have tuned off me and looked for others, but for some reason he stuck with me. Worst of all, instead of QRSing, he sped up every time he repeated his QTH — METUTCHEN, N.J., about 30 or 40 miles away. I'd never heard of it, but I've never forgotten it either. So, I became indoctrinated into casual contesting.

I did like to work the old ORS contests in a very casual way. The most memorable part of those contests was following Ken Keeler around the country. First in 2-land, then in 5-land, then around 6-land. Or was it the other way around? With each new QTH he got bigger and better locations and antennas. But he always won or was close to the top.

Then there was Rusty Epps, W6OAT. He would get in the contests from W1MX when he should have been studying at MIT.

Very fortunately we have a fine vice president who is a first rate contester and is full of enthusiasm to promote all sorts of wonderful activities for this forthcoming year. N6TV, of course. And for our Sec/Treas we have AD6E, a very fast operator who can crank out address labels and deposit slips as fast as he can hand out QSOs in a contest. And a great Jug editor who knows where all the keys on the computer are located, AK6T. And a great group of directors who can hardly wait to begin sorting out your requests for hard-nosed competition in the contests. Looking forward to this action.

News and comments from Gary, WA6VEF

Greetings from Vancouver, BC, and congrats on another FB Jug last month. Here are some tidbits for your next issue.

First, perhaps I can shed some light on the questions regarding the Five Million Point Award. These were brought up by KA6ING and W6REC and published in the last Jug.

The answer to the question on NCCC Club territory may be found by consulting our 1988-89 roster, which contains a copy of NCCC's by-laws. Article III, Section D, defines the club's boundaries as Northern California from the Oregon border to the Tehachapis, and any other area within a 175-mile radius of the club's center, which is presently in Danville, CA. (The club's actual "center" is not specifically defined in the by-laws — there's a good reason for it, but we'll save that discussion for another day!)

Thus, Modoc County scores from W6REC, for instance, would count for the Award, as would, say, a California QSO Party expedition to Del Norte County staged by one of our members, or any score turned in by our contingent in the Reno/Sparks/Carson City area.

However, scores made by a person when he is not a member are a different matter. Although not spelled out in the rules, there is a precedent on this point. Last year (or maybe it was two years ago — my brain is becoming feeble!), the NCCC Awards Committee ruled that scores made by N6IG after September 1986 but before he rejoined the Club could not be applied toward his Five Meg Award. Thus, if W6REC, or any other NCCCer, takes a "sabbatical" from the club, the scores he makes during that period don't apply toward the Award.

I suppose the next board of directors could overrule this precedent. But, the way I see it, the Five Meg Award is an NCCC award, paid for by NCCC membership dues, which should be earned by NCCCers for contest participation only during the time that person is a bonafide NCCC member.

Cure for 2 meter TVI

My 45W 2 meter rig was overloading my TV set and a neighbor's. It so happens that 144 MHz is right between Channels 6 and 7. I bought part No. 5KMT-A/H from Microwave Filter Company, 6743 Kinne Street, E. Syracuse, NY 13057, (800) 448-1666. This is a cable TV filter that attenuates cable TV channels A to H (121.25 to 163.25 MHz) by 50 dB without affecting other channels.

The filter is a rugged metal cylinder, about 4 1/2 inches long and 3/4 inch in diameter, with a male F-connector on one end a female F-connector on the other. It is designed to work with 75Ω TV coax. Place it right before the TV receiver or VCR.

Cost is \$13.95 plus shipping, and they will ship via UPS Blue Label if requested. I charged it on VISA and received the filter in three days. It instantly cured all traces of 2 meter TVI. My thanks to Chuck, AA6G, for steering me in the right direction.

Club member Scotty Williams, AE6U, has been operating from Belize for several weeks and made lots of contacts in the CQ WPX SSB Contest with the special prefix V32. His address is:

In a letter to NCCC, he says: "I made 2200 QSOs with a 100-watt transceiver and a vertical antenna. Actually, the radio is a channelized unit and didn't even have a tuning knob. Nothing fancy like a footswitch, either, just a mobile handheld microphone. I have temporarily (I hope) lost all feeling in my thumb above the knuckle from clenching the PTT. I did work 70 countries, although I didn't have much of a signal. I was probably the first V32 prefix that anybody in the contest had ever contacted. I'll be in Belize for two years and plan to be real active, especially on the low bands. Hope to have the use of a 200-ft tower to hang wire for 160 from."

Scores still need to be straightened out

I am still wrestling with the task of properly formatting members' scores for presentation in the Jug. Much of the info comes in by packet, sometimes partially garbled in transmission, to my Mac computer, and I am having to learn new skills for publishing it. One problem is that packet doesn't handle tabs, so scores come in with a lot of spaces that I have to replace with tabs. A solution might be for the sender to use commas to delimit items of data. I can then simply select commas as delimiters in the table function of Microsoft Word.

If someone gets left out of the tables or is wrongly reported, apologies. Please let me know so that I can make corrections next month.

Meanwhile, some of KI3V's scores have begun to appear in the tables, giving him long-overdue recognition. As you read in the minutes, Rich has been trying for some time to have his scores included. Somehow, they've been omitted until now.

Club QSLs again available

Some time ago, I ran out of those old (but great) NCCC club QSLs — not those really old cards, but the ones with the state map on them enhancing Northern California. I got my last box from NU6S when he had a "going out of business sale" may moons ago. The problem now is: where does one go for replacement cards?

I managed to get the original artwork from NU6S, but the film was not quite up to print quality. Rather than try to fix it up, I decided to try playing with AUTOCAD. Now, I've never used AUTOCAD for anything, but since it was available, what the heck!

After several evenings "fooling around," I finally created a reasonable looking QSL. An expert (someone who's read the manual) could have done it in an hour.

The next problem was where to go to get them printed. I sent away for quotes from the usual QSL print shops and got an excellent bid from Shell Printing, KD9KW.

Bob, N6TV, had a brilliant idea. Contesters are always inundated with QSL requests that are no fun. Most contesters use computers for logging. What Bob did was to find a printer who would print QSLs on form feed stock. Just run the QSLs through your printer. One line of text and the card is ready to go. No sticky labels to fool with! I've seen some QSLs like this where the entire card is done on a dot matrix printer, and I think they leave much to be desired. I am working on software to easily run the printer from an IBM-type PC. My goal is to process a standard contest log such as K1EA, or simply enter the data from the keyboard.

This is all great, but there's a catch. The form feed cards require a minimum order of 10,000 cards! That's about a six-month supply for N6RO, and a little longer for the rest of us. The good news is they are reasonably priced at 2.9 cents per card (plus tax). If this quantity is just too much, but you are still interested in getting club cards, then the

standard loose cards can be ordered from Shell Printing for about 3.5 cents each (box of 1000).

Here is how I'd like to work this. Let me know if you are interested in buying club cards. I will modify my AUTOCAD file, print out camera ready artwork, and mail it to you. You can then choose where to get it printed. For my cards, I glued on an NCDXF symbol. You can do similar things, using ARRL, NCDXC, NCDXF, or whatever you want. I don't have these symbols, so if you want them, you will have to find them yourself. "NCCC orange" is not required. By the time you read this, I should know what other colors are available. Print color is one side only: one color, black!


Scott, N1EE, does well in OMARC Contest
