
## FIELD DAY FLUSHES **OUT SOME SURPRISES**




#### MAKING PLANS TO DO IT AGAIN DE BOB, N6TV



#### STATION DESIGN

SEC/TREAS, WA6SDM LEADS OFF NEW SERIES

DISCUSSING PLANNING AND BUILDING OF IDEAL HAM SET-UP

#### TRANSCEIVER

When I was looking for a replacement to my Kenwood TS-130S, split operation, filters, notch, and good QSK operation were a must. After a six week experience with service, the service was very important. Also I wanted a rig that could handle the key-down RTTY mode at full power. Many memories and other bells were not high on the list. I heard Ten-Tec service was very good. and a phone call to the service department seemed to backup what I heard from other I also like to short-wave listen, so general coverage was also an important factor. After a bit of knob twisting, I decided on the It provided the features I Ten-Tec Paragon. wanted, the service seemed to be better, and it was American made. I also purchased the full set of filters and RS-232 interface. The interface is used to band-switch the amplifier and tuner. The QSK performance is superb, and yes, I have used the service. It is absolutely top-notch. I had the board I needed in two days, replaced it, sent the old one back with a check for \$17. A couple operational features that I have come to like very much are the direct key pad entry of frequency and the scratch pad memory.

#### AMPLIFIER

Wanting to boost the power from the barefoot level, I looked at several choices. Most of the choices involved 220 volts. After carefully examining the plug under the operating table, I realized I had a problem. I don't own the property, so 220 volts is not a choice. Also about this time I was looking to operate the station on solar power (not quite there, but close). So instead of the 1500 watt level, I decided to look at a lower power level that would be more compatible with the solar power goal and the no 220 volt restriction. If I was going to use solar power, 12 or 24 volts seemed to be a better choice. Again, the key-down performance for RTTY was a consideration. This narrowed the choice to one amplifier, the Ten-Tec Hercules II. RS-232 interface on the Paragon also provides the band switch lines so the amplifier will auto switch when the Paragon is switched. To power the amplifier, I have two marine batteries and a 20 ampere power supply. Actually this powers the entire station, except for the computer.

#### ANTENNA TUNER

The Amplifier will work with a 2:1 vswr, but I like it a little lower, and with the low band antenna I need a little help. I use the Ten-Tec 253 automatic tuner. Using the band switch lines from the Paragon, the tuner will auto tune as the bands are changed. In band, a touch of the tune button puts the tuner right on the money.

ANTENNAS

I started out with dipoles. They worked, but multiple bands were difficult. I eventually got a Cushcraft R-5 for 20-10 and dipoles on 40 and 80. The R-5 was chosen because it covered the bands with one antenna and did not require the ground planes needed by a quarter wave vertical. Much better, but I eventually did get a Mosely TA-33 tri-bander. I chose this beam because it was small enough to put on a crank-up mast and would perform better than the R-5. I also liked the construction when compared to the Cushcraft A3. The TA-33 is at 45 feet. The R-5 is still used for WARC band coverage. After not being happy with the performance of the 80 and 40 inverted vees and modeling antennas on the ELNEC antenna program, I took the vees down and put up a Butternut HF-2V. This antenna covers 80, 40 and 30 meters. It is ground mounted and I have 16 radials 25 foot long. Currently I don't have anything on 160 meters, but an inverted L is possible.

#### ANCILLARY EQUIPMENT


I have a MFJ memory keyer, probably because that is what Quement's had at the time. I built the voice keyer that N6IP published in the JUG, a Kenwood TR-9000 for 2 meter packet and a Kantronics Kam for digital modes. The TR-9000 I have had for some time, and I liked the compact size of the Kam. I also have an Ameritron remote coax switch to manage the feed line mess. The rotor is a HY-Gain CD-45. Of course, the computer is a main component of the station. The computer is a 386SX built up from bits and pieces along the way. It in no way resembles the computer I started out with six years ago. Naturally I have CT for most contesting, WF1B's RTTY contest software for RTTY contests, and use the Kantronics Hostmaster II program for packet and non-contest RTTY.



#### NORTHERN CALIFORNIA CONTEST CLUB BY-LAWS

#### ARTICLE I NAME AND PURPOSES

- Section 1: This organization shall be known as the Northern California Contest Club.
- Section 2: The purposes for which this club is organized are to bring together radio amateurs interested in contests; to evaluate the standards of contest techniques and ethics; to encourage participation in amateur radio contests of interest to the members; and to compete as a club in major contest activities.

#### ARTICLE II OFFICES

- Section 1: The principle office of the organization in the State of California shall be located in the City of Danville, County of Contra Costa.
- Section 2: The organization may have such other offices as the Board of Directors may determine or as the affairs of the organization may require from time to time.

#### ARTICLE III QUALIFICATIONS OF MEMBERS

- Section 1: The Club shall be comprised of three classification of members: Full, Associate and Family.
  - A. Full members shall possess a valid amateur radio operator's license and reside in the club area. Full members shall agree to abide by the By-Laws of the Club.
  - B. Associate members shall be only those persons who have at any time fully qualified as Full members. At such time as a Full members moves from the club area, he automatically assumes Associate member status.
  - C. Family Membership is available to families who have two or more licensed amateurs residing in the same household. Membership standards for family members shall be the same as for full members. One family member shall pay full dues and the remaining ones shall pay at the associate member rate. All family members shall be considered full members, except that only one copy of the JUG shall be sent to the household.
  - D. Only Full members have voting privileges and are eligible for club awards.
  - E. The club area is defined as Northern California from the Oregon Border to the Tehachapis, and any other area within a 175-mile radius of the clubs center.

- Section 2: All new members must demonstrate an interest in contests.
- Section 3: Any person desirous of becoming a member shall be nominated by no fewer than three Full members. Said nominee shall file his application through the Club Secretary with nominating signatures affixed, and must be in attendance at the meeting when said application is read in order to qualify for membership.
- Section 4: If the applicant has fulfilled all the requirements, the Secretary shall submit the application to the President on or before the first available meeting date.

The President shall read, or cause to be read, the application, including call letters of the applicant, to the membership. An affirmative vote of 90% of those members present shall constitute acceptance of the applicant. The applicant shall not be present at the time of the ballot.

The Secretary shall advise the applicant of the results of the ballot and shall see that he/she is furnished with a copy of these By-Laws and a current roster.

- Section 5: All Full members may submit their contest scores in the name of the Northern California Contest Club.
- Section 6: Notwithstanding the other provisions of the By-Laws, continuing-Full membership shall be contingent upon active contest participation and good operating procedures. The qualifications of any member may be reviewed by the Board of Directors and reported at any regular membership meeting. Any member may be denied continuing membership upon:
  - A. Recommendation by the Board of Directors
  - B. An announcement in the JUG, and
  - C. A vote to deny continued membership by two-thirds of those present at the next regular meeting.
- Section 7: Any person desirous of reinstatement to full membership shall make payment of prorated dues and be approved by the Board of Directors or may go through the regular new membership procedure outlined in Sections 3 and 4.

#### ARTICLE IV OFFICERS

- Section 1: The officers of the club shall consist of a President,
  Vice-President/Contest Chairman, and a
  Secretary/Treasurer. All said officers shall be elected
  annually by a ballot and by those members in attendance
  at the regular April meeting. They shall hold office for
  a term of no less than twelve months, commencing with the
  meeting at which elected. No officer shall succeed
  himself.
- Section 2: In the event that an officer-of the club (Vice-President, Secretary-Treasurer, or Board member) becomes unable to full fill their term of office, the President shall appoint and obtain the simple majority of the Board of Directors. In the event the President becomes unable to full fill his/her term of office, the Vice-President shall become the President.

#### ARTICLE V BOARD OF DIRECTORS

- Section 1: The affairs of the club shall be managed by its Board of Directors.
- Section 2: The Board of Directors shall consist of the President, Vice-President/Contest Chairman, Junior Past President, Secretary/Treasurer, and three Directors elected by the membership. The terms of office for the three elected Directors shall coincide with those of the Club officers.
- Section 3: The Board of Directors shall meet on the same day as the first regular membership meeting following election of officers and directors without other notice that this By-Law. They shall meet at the same time and place as the membership. Special meetings maybe called by the President. Notice of any special meeting shall be given two weeks previous thereto.
- Section 4: The Board of Directors shall have no power to change the By-Laws. The Board of Directors is authorized to act by unanimous written consent.
- Section 5: The Board of Directors of the NCCC shall prepare a budget once each year. This budget shall be presented to the regular membership at the June meeting. Said budget must be approved by a two-thirds majority of the members present at the June meeting. The officers and Board will be bound to the approved budget during their terms of office.

#### ARTICLE VI

- Section 1: The club shall meet at least bi-monthly on a night and at a place designated by the club President. The membership shall be advised two weeks in advance of the meeting by the Secretary as to the time and place selected.

  Meetings may be closed to visitors as the occasion requires.
- Section 2: Meetings shall consist of the necessary business, conforming to Roberts's Rules of Order, followed by an appropriate program of interest to the members.

#### ARTICLE VII AMENDMENT OF BY-LAWS

Section 1: All amendments to the By-Laws shall require a written petition to the Secretary and have the signatures of at least five Full members. A copy of the proposed amendment and a ballot shall be mailed to the eligible members. The Secretary shall specify a date not less than 30 days nor more than 75 days after the mailing by which the ballots must be received. A two-thirds affirmative vote of the ballots received shall be required for acceptance of the amendment.

#### ARTICLE VIII FEES AND ASSESSMENTS

- Section 1: Full members, Associate members, and Full-time students shall pay annual dues as set by the Board of Directors each year. Dues are due 1 July each year.
- Section 2: Upon recommendation of the Board of Directors, assessments to the membership may be made.

  Associate members shall be assessed one-half the amount of Full members.
- Section 3: Any member delinquent in dues or assessments payable for twelve months shall be automatically dropped from membership.
